White River School District Device Protection Plan 2018-19

What is the Device Protection Plan ("DPP")?

Students and parents are responsible for the Chromebook that is issued to them, just as they are for other district-loaned items such as textbooks, calculators, cameras, athletic equipment, or library books. The DPP provides families some financial protection if the Chromebook needs to be repaired. The DPP is a voluntary plan.

Why Purchase the DPP?

The total replacement cost of the HPx360 Chromebook provided to students is \$425. Participation in the DPP can reduce liability for the student and his/her family if the Chromebook needs to be repaired. Keep in mind that damage caused by gross negligence and willful destruction is not covered by the DPP.

How much does the DPP cost and when is enrollment?

The cost is \$30 (non-refundable) per year, per device. Students eligible for reduced/free lunch pay \$10/\$0 (non-refundable) per year, per device. Participation in the yearly DPP is made available to families *prior* to distribution of the Chromebook.

What is covered by the DPP?

The DPP provides repair (parts and labor) at a reduced cost. Repair costs will vary based on the type of repair that is necessary to make the device operational again. Refer to the 2018-19 Repair Cost Chart in this document for specific limits and costs. Labor costs will be provided to the families at no cost.

The DPP does not cover the following:

- Lost Chromebooks
- Stolen Chromebooks without a police report.
- Damages due to gross negligence or willful destruction/vandalism. Gross negligence is defined as the failure to exercise slight care in the handling of the Chromebook.
- Missing keys.
- Liquid damage. Liquid or water spills into the keyboard typically render the Chromebook unusable and only the screen can be salvaged. Thus, students/families will be fined the full replacement cost of the internal components. BE SURE TO KEEP THE CHROMEBOOK ON A DESK OR TABLE AND AWAY FROM WATER OR DRINKS.
- Charger, cover, stylus, or other peripherals.
- Families who leave the district during the school year but fail to return the Chromebook, will be
 responsible for paying the full replacement cost for the Chromebook in accordance with White
 River School Board Policy 3520 "A student will be responsible for the cost of replacing
 materials or property which are lost or damaged due to negligence. A student's grades,
 transcripts or diploma may be withheld until restitution is made by payment or the equivalency
 through voluntary work."
